Report

Recommendation: THAT the distribution of servicing allocation through the 2020

Regional Allocation Program to the lands shown on the revised map attached as Appendix 1 and to the landowners/developers listed on the revised Tables in Appendix 2 to Report PD-007-20

be endorsed;

AND THAT the Town Clerk be directed to forward a copy of Report PD-007-20 together with the Council resolution to the Region of Halton, the City of Burlington and the Towns of Halton

Hills and Oakville.

REPORT

Background

On January 20, 2002, Council endorsed the recommendations of Report PD-004-20, which was a report recommending the distribution of servicing allocation through the 2020 Regional Allocation Program to specific properties in Milton based upon the expressions of interest received from landowners. Subsequently, the Region has advised that an additional expression of interest has been received from a Boyne Survey landowner, Mazmik Developments Limited, requesting to participate in the upcoming program and reserve 360 single detached equivalent units (SDEs) of servicing allocation for purposebuilt rental units.

Discussion

As outlined in Report PD-004-20, the Region had made available to Milton up to a total of 8,715 SDEs through the 2020 Allocation Program. In total, expressions of interest were received for a total of 8,410 SDEs distributed among the Boyne Survey, Bristol Survey, Sherwood Survey and Trafalgar Secondary Plan areas. Staff recommended that Council endorse the distribution of servicing allocation to all the landowners that had submitted expressions of interest for a number of reasons, most notably because it would support a continuous, quantifiable and predictable rate of development over the six year duration of the program. In addition, it would provide options with respect to the orderly progression

of development and it would complete developing neighbourhoods, increasing the supply and diversity of housing types.

Staff has reviewed this additional request and notes the following. The Mazmik property, shown as M57 on the map included in Appendix 1 to this report, is located in the easterly of the Town Secondary Mixed Use Nodes planned for the Boyne Survey. There are a number of applications which have already been received and/or granted some level of planning approval in this area by the Town. Further, this request will complement development of other properties in this area of the Boyne Survey for which allocation has already been endorsed by Council, thereby completing the development of these neighbourhoods. Finally, Mazmik proposes the development of purpose-built rental housing units, adding to the diversity of housing stock available within the Town.

While Mazmik Developments Limited has expressed interest in 360 SDE's, due to the timing of receipt of the request and the recommendations of the previous report, there are only up to an additional 305 SDEs for the Town to distribute. As the program continues to be finalized, staff will continue to work with the Region to monitor reserved SDEs so that in the event that allocation distributed to Milton becomes available, developments such as this would have an opportunity to reserve additional SDEs to support the full build-out of their projects.

Accordingly, staff recommends that Council endorses the distribution of the balance of the available SDEs distributed to Milton, being 305 SDEs, to Mazmik Developments Limited. An updated map as well as tables illustrating the inclusion of the Mazmik request are appended to this report.

Financial Impact

The financial implications of the 2020 Regional Allocation Program were outlined in report PD-004-20. The additional units identified in this report will further support a more diversified distribution of allocation among developers, providing greater continuity and predictability of residential development targets for the Town.


