1	Please increase total number of full time fire-fighters employed by the Town.
2	It is great that Main Street, Milton got attention with new paving etc in 2020. Thank You Perhaps the town could address two bridges over the 16 Mile Creek on Main Street east of Commercial and on Martin Street north of Mill Street. Both these bridges are built over top of the OLD bridge infrastructure and inhibit the flow of water through the creek bed into the channeled creek area. In a potential flood the water would back up at the entrance / or around both these bridges causing flooding in the properties behind the bridges (Millside Drive, Rotary Park, Towne Square, old post office, old town hall property and downtown Milton heritage buildings). In order to prevent the flooding of downtown Milton heritage buildings - the Clements property as well - a permanent BURM should be erected along the 16 Mile Creek on the access road to Rotary park to stop any flood waters from escaping from the 16 Mile Creek water flow. The Clements properties in the flood plain are heritage buildings and we need to be allowed to PROTECT our buildings and the PEOPLE who work in them whether it is Region of Halton Health centre or the two restaurants or stores that keep people coming to the downtown core to shop and appreciate the uniqueness of the Milton heritage and the small town atmosphere.
3	 Having a 395 page document with lots of pretty pictures, displays the excess that is contained within the organization.
