Recommendation:	THAT Application Z-29/21 for a Temporary Use Zoning By-law Amendment to the Town of Milton Zoning By-law 016-2014, as amended, to change the current IA Zone (IA*267) to a Temporary Use Minor Institutional Use with Site Specific Provisions Zone (T14-IA) to permit a Secondary School for a period of two-years, on lands municipally identified as 675 Kennedy Circle West, BE APPROVED; AND THAT staff be authorized to bring forward an amending Zoning By-law in accordance with the Draft By-law attached as

EXECUTIVE SUMMARY

The Halton Catholic District School Board is requesting a Temporary-Use Zoning By-law Amendment for Milton #10 Catholic Elementary School. The purpose of the application is to temporarily allow for Milton #10 Catholic Elementary School to operate as a Secondary School for two (2) years. Further, the Temporary-Use Zoning By-law would also permit the relief of the base parking requirement of 4 parking spaces per classroom to 2.43 spaces per classroom.

Milton #10 Catholic Elementary School was site plan approved (SP-19/20) April 28, 2021. At this time, the School is under construction and is expected to be complete by Spring 2022. No changes to the built form of the school or parking lot area are proposed as part of the Temporary-Use Zoning By-law Amendment.

The statutory public meeting was held on March 21, 2022. Five members of the public spoke at the meeting. Staff have also received a number of written submissions which are addressed under the Summary of Issues section of this report.



EXECUTIVE SUMMARY

Since the public meeting in March 2021, Halton Catholic District School Board received Ministry approval for Milton No. 3 Catholic Secondary School (St. Kateri Tekakwitha) and the approval tender for the construction is expected to proceed in spring 2022. Staff recommends that the applications be approved, that the amended Zoning By-law be adopted with an expiry date of August 31, 2024.

REPORT

Background

Z-29/21: Milton Catholic Elementary School Temporary Use Zoning By-law

Owner: Halton Catholic District School Board (HCDSB)

Applicant: Jeff Kenny, Strategy 4 Inc., 100-2620 Bristol Circle, Oakville, Ontario L6H 6Z7

Location/Description: Milton Catholic Elementary School #10 is known municipally as 675 Kennedy Circle West (See Figure 1 - Location Map). The property is located within Mattamy's Martin East Plan of Subdivision (20M-1219) and located east of Sixteen Mile Creek, south of Louis St. Laurent and north of Britannia Road. At this time, Milton Catholic Elementary School #10 remains under construction.

Proposal: The applicant is requesting approval of a Temporary-Use Zoning By-law for Milton Catholic Elementary School #10. The purpose of the application is to allow for the Elementary School to operate as a Secondary School for a maximum of two (2) years (until 2024). The goal for the proposal is to allow for accommodations of secondary school students within the HCDSB who are currently being bussed to the City of Burlington. The School is currently under-construction and plans to be completed by Spring 2022. The applicant is also proposing to permit relief of the base parking requirement of 4 parking spaces per classroom to 2.43 per classroom required for secondary schools.

Proposal Background Information: In November 2019, HCDSB initiated a School Boundary Review for the secondary plan in the Town of Milton, to address accommodation pressures at Bishop P. F. Reding CSS and St. Francis Xavier CSS, and to establish boundaries for the proposed St. Kateri Tekakwitha CSS.

The School Boundary Review Committee was composed of parent representatives from all ten elementary schools and the two secondary schools in Milton, as well as student representatives from the two secondary schools. Additionally, public feedback was gathered from the Milton community through two public information meetings, three public feedback surveys, and opportunities to delegate to the Board.



Background

Following the consultation process, in November 2020, the Board of Trustees approved an interim and ultimate accommodation plan for the Town of Milton secondary panel, as recommended by the School Boundary Review Committee.

In May 2021, HCDSB initiated a School Boundary Review for the Boyne area in the Town of Milton, to address accommodation pressures at St. Scholastica CES, and to establish boundaries for the proposed Milton #10 CES. The School Boundary Review Committee was comprised of parent representatives from the Boyne area. Additionally, public feedback was gathered from the Boyne community through a public information meeting, a public feedback survey, and an opportunity to delegate to the Board.

Following the consultation process, in November 2021, the Board of Trustees approved an interim and ultimate accommodation plan for the Town of Milton secondary panel, as recommended by the School Boundary Review Committee.

HCDSB is now working through the appropriate municipal approvals to achieve the above accommodation plans, as recommended by the respective School Boundary Review Committees, and ultimately approved by the Board of Trustees.

Under the plans, the Milton No. 10 CES building would be used as a secondary school for 2 school years (2022-23 and 2023-24). Elementary students that ordinarily would attend the Milton No. 10 CES building will be accommodated at other elementary school within Milton, with transportation provided as per Board policy. The accommodation plans ensure that Milton students are attending a school within Milton, which was the primary concern for the School Boundary Review representatives.

Since the Public Meeting for the proposed temporary use on March 21, 2022, HCDSB has received Ministry approval for Milton No. 3 Catholic Secondary School (St. Kateri Tekakwitha) and the approval tender for the construction is expected to proceed in spring 2022. This funding will allow for an additional secondary school in southeast Milton.

The following documents have been submitted by the applicant in support of the Temporary-Use Zoning By-law Amendment application.

- Existing Conditions Plan, prepared by Statregy 4 Inc. and dated July 2019;
- Planning Justification Report, prepared by Strategy 4 Inc., and dated November 2021;
- Traffic Impact and Parking Justification Study, prepared by GHD Engineering and dated November 3, 2021; and
- Draft Temporary Use Zoning By-law, prepared by Strategy 4 Inc. and dated January 21, 2021.



Background

Planning Policy

Provincial Policy Statement (2020)

The current Provincial Policy Statement includes policies that support the creation of heathy, livable and safe communities by ensuring that necessary infrastructure and public service facilities (including educational facilities) will be available to meet current and projected needs. The document also contains policies that encourage municipalities to optimize the use of existing infrastructure and public facilities wherever feasible.

The proposed development is consistent with provincial policy as it ensures that secondary school facilities will be available within the Town of Milton for Town of Milton residents. The proposal also relies on and supports existing public infrastructure.

Halton Region Official Plan

With respect to Regional policies, the subject lands are designated Urban Area in the Region's Official Plan. The proposal to operate Milton Catholic Elementary School #10 as a secondary school for two-years conforms to the permitted uses within the Urban Area.

Town of Milton Official Plan

Milton Catholic Elementary School #10 is designated as Residential Area on Schedule B in the Town of Milton Official Plan. The Residential designation permits Local Institutional Uses. Additionally, the lands are located within the Boyne Survey Secondary Plan and are identified as Residential Area on Schedule C.10.C.

Section C.10.5.1.1 d) of the Boyne Survey Secondary Plan states that local institutional uses which by their activity, scale and design are compatible with residential uses and which serve adjacent residential areas including elementary schools (in addition to those located within the Neighbourhood Centre Areas), libraries, places of workshop, day care facilities, and community centres in accordance with specific criteria set out in Sections 3.2.3.6 and 3.2.3.7 of the Official Plan.

Planning staff note that the proposed Temporary Use Zoning By-law Amendment will utilize the existing building and site which has been approved and conforms to the Official Plan. This proposal conforms to the permitted uses and policies within the Official Plan.

Zoning By-law 016-2014, as amended

Milton Catholic Elementary School #10 is currently zoned I-A*267. The I-A zone does not permit secondary schools. The current application is seeking permission to temporarily permit a secondary school to locate within the I-A*267 Zone for a period of a 2-year term.

It is also noted the Zoning By-law requires a minimum of 4 parking spaces per classroom for secondary schools. The current application is also seeking relief to permit parking for a secondary school be provided at a rate of 2.43 spaces per classroom.



Background

A Draft Zoning By-law is attached as Appendix 1.

The *Planning Act* specifies that a Temporary Use By-law can only be approved for a maximum of three (3) years. Any extensions beyond three (3) years would require additional Council approval. At this time, the applicant is seeking to permit the use for two (2) years.

Site Plan Control

A Site Plan (SP-19/20) was approved in April 2021 for the subject property. No physical changes or development is proposed as part of the Temporary-Use Zoning By-law Amendment and as a result, if approved, a Site Plan revision is not warranted.

Discussion

Public Consultation

Notice of a complete application was provided on December 8, 2021. The applications were circulated to the internal departments and external agencies on December 15, 2021.

The HCDSB and the applicant held a Public Open House virtually, on February 22, 2022. This Open House consisted of a presentation on the proposed development and a question and answer period. Town staff were in attendance to take note of questions and comments provided.

A Statutory Public Meeting was held on March 21, 2022 and 5 members of the public spoke at the meeting in objection to the proposed development. Further, staff has received public written comments from surrounding residents who have noted objections to the applications. Their concerns are related to altering plans and concerns surrounding children being bused to another school and unable to walk to the proposed school. Further, a majority of the comments provided details on the location of the proposed school being a main contributor to why families chose to buy homes within close proximity with the goal of their children being able to walk to and from school. Technical concerns identified were related to traffic and parking impacts as well as the concern of having the temporary-use made into a permanent use. All written submissions have been attached as Appendix 2 to this Report. All of the technical issues raised are addressed in the "Summary of Issues" section of this Report.

Agency Circulation

The application was circulated to internal departments and external agencies. All departments and agencies have no objection to the approval of the application as proposed.

Summary of Issues



Discussion

Temporary Use Zoning By-law and Revision to Original By-law for One Year to Two Year

Pursuant to the Planning Act, temporary use by-laws can be authorized through Council and have a time limit of a maximum of three years from the passing of the By-law. The Town typically prefers to limit this to one year as it gives an opportunity to better assess the impact of the application following the one year and if it is determined that the temporary use is operating without issue, the by-law can be further extended by Council. However, the school board has made it clear that it will require a minimum of two years for the temporary use as the Milton # 3 Catholic Secondary school (St. Kateri Tekakwitha) is anticipated to be open in September 2024. Due to this update, the Temporary-Use Zoning By-law Amendment has been revised to request permission to allow for Milton #10 Catholic Elementary School to operate as a secondary school for two-years instead of the previous request for one year.

As such, the By-law has been revised accordingly to reflect this two year time frame. Beyond the two years, an extension to a Temporary Use By-law would require Council approval.

Once the Temporary Use Zoning By-law expires, the applicant would be required to operate the existing school as an elementary school and the required parking would be applicable for this use.

Planning staff understand the public comments identifying concerns that the proposed secondary school use could become a permanent solution for the school board but as noted above, the Temporary Use Zoning By-law will expire and the HCDSB would need to re-apply for any extension which would once again go through a public process and ultimately to be decided on by Town Council.

Traffic Impacts & Parking Demand

As part of the proposed temporary-use, the applicant has proposed to permit relief of the base parking requirement of 4 parking spaces per classroom to 2.43 per classroom required for secondary schools. A Traffic and Parking Assessment dated November 3, 2021 and prepared by GHD Engineering Group was submitted in support of the proposed development. Transportation staff reviewed the Assessment and confirmed that the expected traffic generated by the temporary proposed secondary school would be comparable to the approved elementary school. Further, the proposed secondary school use would result in an overall reduction in traffic from the approved elementary school. Further, staff noted that there is a minor increase in traffic during the morning peak period, however there is residual capacity in the surrounding intersections and no improvements would be required for the proposed temporary school.



Discussion

Daycare Facilities

HCDSB has confirmed that the daycare facilities that were included in the proposed elementary school will continue to operate when the school opens and will not be impacted by the proposed temporary-use of the secondary school.

Related Subdivision & Information

Staff understand the concern from nearby residents regarding decisions to purchase in this neighbourhood based upon school accommodation for their children. All applications for subdivision approval are circulated to all school boards for review and comment, and often, conditions and warning clauses to be included in subdivision agreements and agreements of purchase and sale are included. As part of the related subdivision approval for this subdivision, the subdivision agreement included Schedule "M" which provides warning clauses and restrictive covenants to future purchasers. HCDSB did include a warning clause that stated that prospective purchasers are advised that Catholic school accommodation may not be available for students residing in this area, and that you are notified that students may be accommodated in temporary facilities and/or bussed to existing facilities outside the area.

Conclusion

Planning staff is of the opinion that the proposed temporary-use, while not the ideal accommodation preferred by the School Board, provides the opportunity for Town of Milton students to attend secondary school within the Town of Milton. Should the application not be approved, students would be required to attend secondary schools in Burlington or Oakville.

Staff acknowledges that the proposed relief to the base parking requirement may result in traffic impacts on the adjacent neighbourhood during peak periods but there will be an overall reduction in traffic as the school operates temporarily as a secondary school. For this reason, staff recommends that the Temporary Use By-law expire on August 31, 2024. This provides an opportunity for Council, staff and the public to assess any impacts prior to permitting an application to extend the Temporary Use Zoning By-law to 2024, should it be required. However, it is noted that it is the intent of the School Board for this to be a temporary solution to the current accommodation issues, and the school will return to an elementary school use once the new Secondary School is complete.

As such, staff recommends that the application be approved, that the amended Zoning By-law be adopted with an expiry date of August 31, 2024.




Figure 1 - Location Map Figure 2 - Existing Conditions Site Plan Appendix 1 - Draft Temporary Use Zoning By-law Amendment Appendix 2 - Public Comments

BY-LAW XXX-2022

BEING A BY-LAW TO AMEND THE TOWN OF MILTON COMPREHENSIVE ZONING BY-LAW 016-2014, AS AMENDED, PURSUANT TO SECTIONS 34 AND 39 OF THE *PLANNING ACT* IN RESPECT OF THE LANDS DESCRIBED AS BLOCK 243 PLAN 20M-1219 FORMER GEOGRAPHIC TOWNSHIP OF TRAFALGAR, TOWN OF MILTON, REGIONAL MUNICIPALITY OF HALTON (HALTON CATHOLIC DISTRICT SCHOOL BOARD) - FILE: Z-29/21

WHEREAS Section 39 of the Planning Act, as amended, authorizes Municipal Councils to pass by-laws to authorize the temporary use of land, buildings, and structures for a specific period of time;

AND WHEREAS the Council of the Corporation of the Town of Milton deems it appropriate to amend Comprehensive Zoning By-law 016-2014, as amended, to allow the proposed use for period ending August 31, 2024;

AND WHEREAS the Town of Milton Official Plan provides for the lands affected by this by-law to be zoned as set forth in this by-law;

NOW THEREFORE the Municipal Council of the Corporation of the Town of Milton hereby enacts as follows:

- THAT Schedule A to Comprehensive Zoning By-law 016-2014 is hereby further amended by changing the existing by changing the existing Site Specific Minor Institutional (I-A*267) to Temporary Site Specific Minor Institutional Zone (T15-I-A*267), shown on Schedule A attached hereto.
- 2. THAT Section 13.3 of Comprehensive Zoning By-law 016-2014, as amended, is hereby further amended by adding Section 13.3.1.15 to read as follows:

Additional Permitted Uses:

i) Secondary School

Special Site Provisions:

- i) Notwithstanding the provisions of Section 5.8.2 ii, Table 5G (38-2019), parking for a Secondary School Shall be provided at a rate of 2.43 spaces per classroom.
- **3. THAT** notwithstanding Sections 1.0, 2.0, 3.0 and 4.0 of this By-law, this By-law shall expire on August 31, 2024, unless the Council of the Corporation of the Town of Milton has provided an extension by amendment to this by-law prior to expiry.

4. THAT if no appeal is filed pursuant to Section 34(19) of the *Planning Act*, R.S.O. 1990, c. P.13, as amended, or if an appeal is filed and the Ontario Land Tribunal dismisses the appeal, this by-law shall come into force on the day of its passing. If the Ontario Land Tribunal amends the by-law pursuant to Section 34 (26) of the *Planning Act*, as amended, the part or parts so amended come into force upon the day the Tribunal's Order is issued directing the amendment or amendments.



Hello Taylor,

I am writing to you regarding the Elementary Catholic School at 675 Kennedy Circle. We are aware of the proposal for this spot to become a secondary school. This proposal directly impacts our family as the elementary school was the reason we purchased our home in this location, and this temporary proposal would displace our son to a school outside of his neighbourhood. I think it is important to stress that I understand why the proposal has been made. Unfortunately, this

temporary proposal actually takes one problem and turns it into three: 1. High school students are **still** without a permanent home

2. Current Elementary-aged students, as well as those that are about to enroll (such as our son), **will continue to be displaced** outside their neighbourhood to accommodate for the temporary secondary school proposal.

The neighbourhood will lose the planned daycare centre (for up to 88 children) that was part of the elementary school plans. Many families depend on this program being available in the neighbourhood. When we spoke to our neighbours, many of them were not informed of the proposal or did not receive the same notification as we did. We started a petition to help increase awareness for those directly affected by this proposal. You can find the petition here: https://chng.it/cQCWyVTnk5

We know a future public forum will be available for our neighbourhood that we plan on attending, but we want to make sure our voice is heard. This proposal truly does not help to resolve the high school problem, and only causes multiple additional problems for elementary aged children.

Hi Ryan, Thank you for your response, you have been available to answer our questions and we are very appreciative of that.

Yes this is a very unfortunate situation, and I'm not here to lay blame as there are many areas of government and planning that dropped the ball here but I think we can all agree, we need a better plan. This plan or recommendation is a very poor choice and now doubles or triples the impact and stress on more families and much younger children.

Yes, We do feel for the high school students and their families that have been temporarily displaced to Burlington, this is not right and I would totally understand their frustration. However, even most of those families don't think that more disruption and stress should now be added to other families and much younger children. These are high school students and young adults who are; 1. Already used to this change and 2. More mature and independent to be bussed/transported vs kindergarten and junior grade students.

Due to this school already being delayed in the community, many of us held our children back via virtual learning or in other schools further away so not to impact their changing schools and the stress and impact that comes with it, and here we are faced with that exact situation. And it sounds like with this "plan" the elementary children will likely have to be shuffled to another school yet again for the 2nd year!? This is absolutely unacceptable and we are astonished that anyone would recommend this. We thought children's mental health was a top priority for the school board? Many families don't feel safe putting their young kindergarten or early grade children on a bus and many parents don't drive so then what? Having elementary schools within walking distance is a must for young children and families.

Also we know this is currently just a "recommendation" and still has to be approved by the Town of Milton via the zoning bylaw change for it to go forward, and we as residents and parents will be mobilizing and speaking up to ensure our voices are heard. This school will not be taken away from our children however "temporary" it may be.

I come to you not only to voice my concerns but have also put some thought into possible solutions; here's a few ideas that I would recommend and I hope will be considered by the school board:

1. Use Virtual learning to split up physical school time/space in one or more High Schools in Milton over the next 2 years. We have the technology and platforms in place already and many students and families that embrace it. Also this saves on fuel and transportation costs.

2. Consider using staggered start and end times - yes some students and teachers will have to start school earlier some weeks or stay at school later other weeks but that may be better than being bussed out of town or dealing with overcrowded class rooms.

3. Combination of 1 & 2 above.

Hi Dan,

In the Fall of 2020, a school boundary review panel recommended that we use the Milton No. 10 school for secondary students and hold the elementary students elsewhere until the new secondary school in south Milton is complete. This was to avoid having to send the secondary students to Burlington, which is where the students are currently attending until the Milton No. 10 school building is complete. The Board of Trustees accepted this recommendation in November 2020. We are expected to finish construction of the Milton No. 10 building in May 2022. Thus, for September 2022, the secondary students from southeast Milton will attend the Milton No. 10 building, while the elementary students in the Boyne area will continue to go to St. Scholastica CES. It is an unfortunate situation, but the provincial funding and approvals have not kept pace with the growth in Milton, and the Board has had to find to creative solutions to avoid sending students to other municipalities due to the lack of student accommodations.


