Subject: Purchasing Various

Staff Recommendation: THAT Council receive for information, the contract increase by delegated authority to Compugen Technologies for network and related switches throughout the Town, and for Sherwood Community Centre, to support the HVAC, security system/access, workstations, POS and Wifi connectivity. The contract increase is in the amount of \$69,621 (exclusive of HST), as outlined in Schedule A;
