# THE CORPORATION OF THE TOWN OF MILTON

# BY-LAW NO. 028-2020

BEING A BY-LAW TO AMEND BY-LAW NO. 1984-1, AS AMENDED, BEING A BY-LAW TO REGULATE TRAFFIC AND PARKING ON HIGHWAYS UNDER THE JURISDICTION OF THE TOWN OF MILTON

**WHEREAS** the Council of the Corporation of the Town of Milton deems it expedient to amend By-law No. 1984-1, as amended, being a By-law to regulate traffic and parking on highways under the jurisdiction of the Town of Milton;

**NOW THEREFORE** the Council of the Corporation of the Town of Milton hereby enacts as follows:

- THAT Schedule 6, Section 5 (9)(v) NO STOPPING AT ANYTIME SIGNS ON DISPLAY to By-law No. 1984-1 is amended as described in Schedule "C" to this By-law;
- THAT Schedule 6, Section 5 (9)(v) NO STOPPING AT ANYTIME SIGNS ON DISPLAY to By-law No. 1984-1 is amended as described in Schedule "D" to this By-law;
- THAT Schedule 16, Section 9 (1)(a) U-TURNS SIGNS ON DISPLAY to By-law No. 1984-1 is as amended as described in Schedule "E" to this Bylaw;
- 6. **THAT** Schedule 26, Section15 (2) HEAVY TRAFFIC PROHIBITED to Bylaw No. 1984-1 is as amended as described in Schedule "F" to this By-law;
- 7. **THAT** Schedule 26, Section15 (2) HEAVY TRAFFIC PROHIBITED to Bylaw No. 1984-1 is as amended as described in Schedule "G" to this By-law;
- 8. **AND THAT** this By-law shall come into full force and effect when the appropriate signs have been erected and are on display.

9. **AND FURTHER THAT** all other provisions of By-law No. 1984-1, as amended, remain in full force and effect.
