• Please describe the issue you intend to present:

Council approved report COMS-001-20 "Climate Change – Corporate Initiatives & Update" on April 27, 2020, which provided an overview of how the portfolio of climate change was being managed, current gaps and opportunities, a list of 'green' initiatives the Town of Milton completed or was in the process of completing, and a proposed 2020 work plan which Council subsequently approved. As part of the commitment to becoming a member of the Partners for Climate Protection, Council must approve the resolution as outlined.

• Please describe specific actions you want Council to take:

I would like Council to give an update on how effective the Climate Change work plan's activities have been thus far as well as identify areas for improvement and provide rationalizations for budgetary considerations for this report. I would also like Council to provide further guidance to Town staff on the list of priorities (if previously identified) to address the climate emergency declared in July 2019 and help them produce a report on activities and projects undertaken to address the climate emergency and assess how effective the declaration has been. I would like to see what budgetary considerations and resource allocation have been provided to the policy development process and for implementation since the climate emergency was declared.

- Please provide your comments in support of or in opposition to the staff recommendation:

As per COMS-001-20:

On July 22 2019, Council declared a "Climate Emergency" and Resolution 194-19 directed staff to undertake the following actions:

1 - To include a staff resource dedicated to Sustainability and Energy Management in the 20202 budget for Council consideration;

2 - Direct staff to inquire and provide council with a report as to long term potential cost benefits of transitioning Town's fleet to electric vehicle where possible

3 - That staff provide an annual update to Milton Council on climate change mitigation

4 - That staff consider all opportunities to include language in future policyplanning work that acknowledges climate change

5 - That staff are directed to inquire and provide council a report as to what the Town of Milton can do to strongly encourage the development community to include EV charging stations in future medium to high-density application. A subsequent Notice of Motion was made during the 2020 budget deliberations and Resolution 248-19 was passed and indicated "THAT consideration of a Sustainability and Energy Manager be deferred until 90 days following the appointment of the permanent CAO for the Town of Milton".

I am in support of the staff recommendations but I wish to see all the items listed here, especially those items that have been deferred, to be addressed in a

meaningful manner and rationalizations provided as to why some of the items listed have not been implemented yet. I would also request that the rationale be provided as to where these items were considered in the budget.
