

THE CORPORATION OF THE TOWN OF MILTON

BY-LAW NO. 006-2021

BEING A BY-LAW TO AMEND THE TOWN OF MILTON COMPREHENSIVE ZONING BY-LAW 016-2014, AS AMENDED, PURSUANT TO SECTION 36 OF THE PLANNING ACT IN RESPECT OF THE LANDS DESCRIBED AS , PART OF LOT 7, CONCESSION 1, FORMER GEOGRAPHIC SURVEY OF TRAFALGAR, TOWN OF MILTON, REGIONAL MUNICIPALITY OF HALTON (MATTAMY MILTON WEST LIMITED) TOWN FILE: Z-18/20

WHEREAS the Council of the Corporation of the Town of Milton is empowered to enact this By-law by virtue of the provisions of Section 36 of the Planning Act, as amended;

AND WHEREAS notice of intention to remove the Holding symbol has been provided in accordance with the regulations of the Planning Act, as amended;

AND WHEREAS the Council of the Corporation of the Town of Milton deems it appropriate to remove the Holding symbol;

NOW THEREFORE the Municipal Council of the Corporation of the Town of Milton hereby enacts as follows:

- 1.0 THAT** Schedule A to Comprehensive Zoning By-law 016-2014, as amended, is hereby further amended by changing the existing Residential Medium Density 1 – Site Specific (RMD1*269-H34, RMD1*269-H39 and RMD1*269-H34 & H39) to a Residential Medium Density 1 – Site Specific (RMD1*269) Zone as shown on Schedule A attached hereto.
- 2.0 THAT** Section 13.2.1.75 is amended by adding the date that the H34 holding provision is lifted.
- 3.0 THAT** Section 13.2.1.78 is amended by adding the date that the H39 holding provision is lifted.
- 4.0** This by-law shall come into force and effect on the day of its passing.

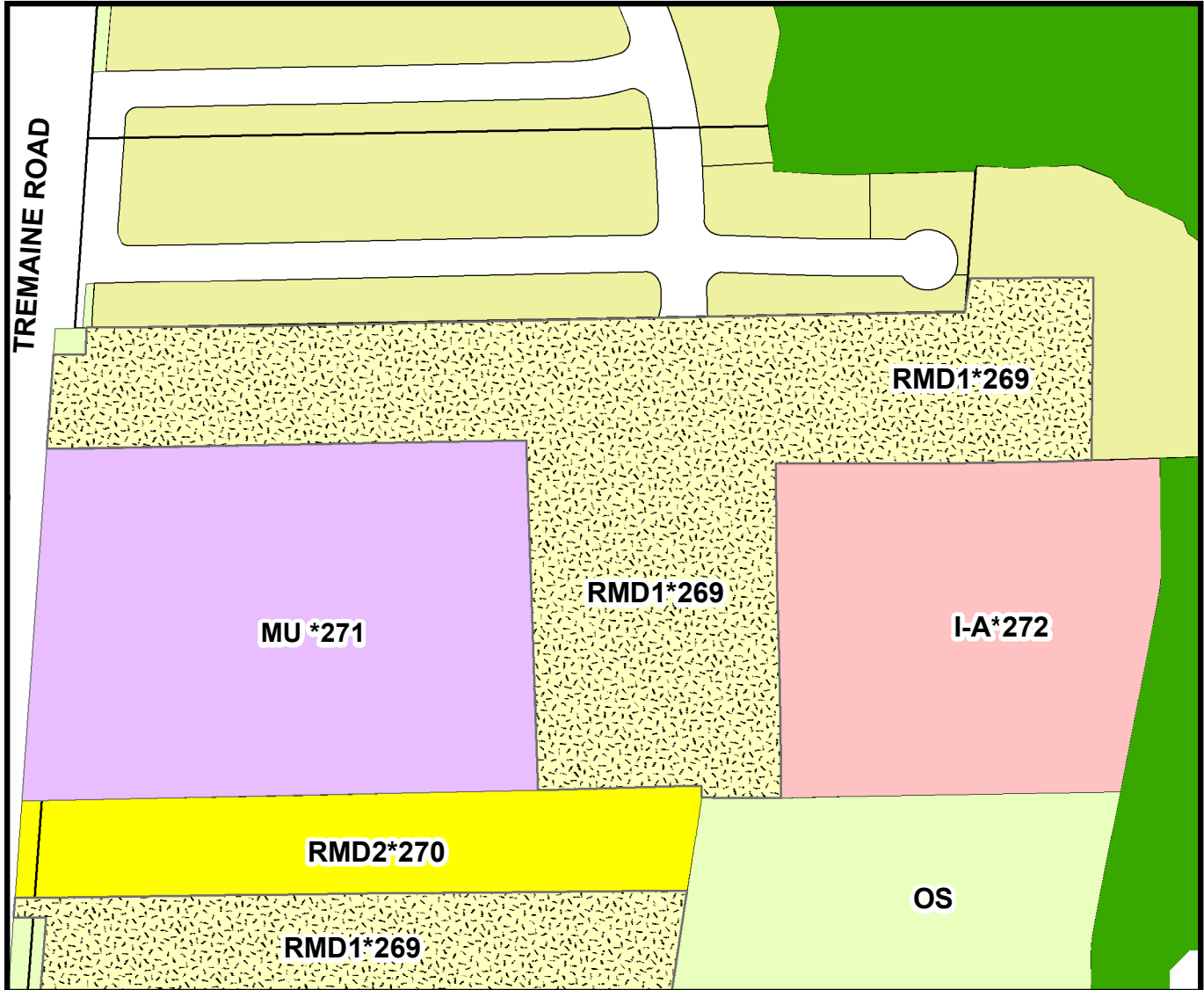
