## THE CORPORATION OF THE TOWN OF MILTON

## BY-LAW NO. 112-2021

BEING A BY-LAW TO AMEND THE TOWN OF MILTON COMPREHENSIVE ZONING BY-LAW 016-2014, AS AMENDED, TO REMOVE A HOLDING PROVISION (H38), PURSUANT TO SECTIONS 34 AND 36 OF THE PLANNING ACT IN RESPECT OF THE LANDS DESCRIBED AS LOTS 61, 62, 63 AND 64 ON REGISTERED PLAN 20M-1230, LOTS 131, 132, 133, 134, 135, 136 AND 137 ON REGISTERED PLAN 20M-1236 AND LOTS 207 AND 208 ON THE DRAFT PLAN OF SUBDIVISION 24T-14014/M, BEING PART OF LOT 7, CONCESSION 1, FORMER GEOGRAPHIC TOWNSHIP OF TRAFAGLAR, TOWN OF MILTON, REGIONAL MUNICIPALITY OF HALTON (MATTAMY (MILTON WEST) LIMITED) - TOWN FILE Z-24/21

**WHEREAS** the Council of the Corporation of the Town of Milton is empowered to enact this By-law by virtue of the provisions of Sections 34 and 36 of the Planning Act, as amended;

**AND WHEREAS** notice of intention to remove the 'H38' Holding symbol has been provided in accordance with the regulations of the Planning Act, as amended;

**AND WHEREAS** the Council of the Corporation of the Town of Milton deems it appropriate to remove the 'H38' Holding symbol;

**NOW THEREFORE** the Municipal Council of the Corporation of the Town of Milton hereby enacts as follows:

- 1. **THAT** Schedule A to Comprehensive Zoning By-law 016-2014, as amended, is hereby further amended by changing the existing Residential Medium Density 1 Site Specific 269, with holding provision 'H38' (RMD1\*269-H38) Zone symbol to a Residential Medium Density 1 Site Specific 269 (RMD1\*269) Zone symbol for the lands described as Lots 61, 62, 63 and 64 on Registered Plan 20M-1230; Lots 131, 132, 133, 134, 135, 136 and 137 on Registered Plan 20M-1236 and Lots 207 and 208 on the Draft Plan of Subdivision 24T-14014/M, as shown on Schedule A attached hereto.
- 2. **THAT** Section 13.2 is amended by adding the date that the H38 holding provision applicable to Section 13.2.1.77 is lifted.
- 3. This by-law shall come into force and effect on the day of its passing.


