- **Please describe the issue you intend to present:**
A large majority of our neighbourhood do not support Milton #10 becoming a temporary high school. A lot of us depend on the school staying an elementary school. We also feel lied to and let down by the Halton District Catholic School board. Only a handful of homes received a notice about the change and many families still do not know about the situation. We have a growing petition with over 409 signatures from families of the neighbourhood. We do not support the change.
- **Please describe specific actions you want Council to take:**
We want the Council to not approve the temporary use of Milton #10 as a high school, keep it as an elementary school, and push for the high school to be built faster.
- **Please provide your comments in support of or in opposition to the staff recommendation:**
The temporary proposal was submitted by the HCDSB to find a new home for Secondary School students who are displaced due to delays in the construction of their new school. Unfortunately, this temporary proposal actually takes one problem and turns it into three: 1) high school students are still without a permanent home. 2) current elementary school students as well as those about to enrol, will continue to be displaced outside of their neighbourhood to schools that are already over capacity (St. Scholastica). 3) while this proposal has been stated as being temporary, the HCDSB has made it clear that their new secondary school will not be ready for at least 2-4 years. This is drastically different than a temporary proposal that requests for 1 year (with a possible extension).
