Opposition to staff report recommendation in DS-039-22 ; opposition to the approval of by-law amendment related to Zoning file: Z-29/21 - Halton Catholic District School Board - 675 Kennedy Circle West

Deny by-law amendment and maintain school as an elementary school as intended.

- **Please provide your comments in support of or in opposition to the staff recommendation:**
 1. We relocated to Milton from Orangeville in August 2020, purchasing our home because of its proximity to the subject school. We wanted to settle into our new home before our young son begins school so he can go to the same elementary school from Jk-Grade 8. Our son will begin JK in September 2023 and if approved, will have to either be re-routed to some unknown school during the time the subject school is used as a highschool or we will enroll him in the public elementary system . Our preference is to enroll him in catholic elementary but I do not wish to uproot him after he begins his school elsewhere and have to leave familiarity and friends behind.
 2. I understand the Catholic School Board did a boundary review and community consultation however; the affected community was not established as it was still under construction therefore; we were not engaged and consulted in this decision-making process. The first time we heard of this proposal was a letter sent to us in November 2021 after decisions had been made. As a taxpayer to the Catholic School Board, I am incredibly disappointed in their approach to engaging our community and their timing of consultations given we are the ones most affected by this decision.
 3. I understand the Catholic School Boards desire to have all enrolled students attending in Milton but the solution to have to send my 4 year old to another school and then return in a year or 2 is not a suitable solution. I also understand the Catholic School Board has experienced lower enrollment having to send high school students to Burlington however; if this amendment is approved, then they will likely see lower enrollment for elementary as we will enroll permanently in the public school board to avoid disrupting our young son's education.
 4. The school may belong to the Catholic School Board but this is our community and our home. Situating a high school with 400-800 students in the middle of our subdivision is not appropriate. We do not want the vehicle traffic, foot traffic of students coming and going from shopping centres north of our subdivision.
